

Canmore Registry & Licence Relocating to Alberta from Another Country (Reciprocal)

Clients originating from a country that has signed a "Reciprocal Licensing Agreement" with Alberta and who are lawfully entitled to be or to remain in Canada and have now established residency in Alberta may exchange their valid operator's Licence for an Alberta operator's Licence.

In addition to the **United States**, the following countries have a Reciprocal Licensing Agreement with Alberta:

***MUST** provide 2 years driving history or full re-testing required

To obtain an Alberta Driver's Licence you are required to provide the following **two pieces of identification & one-piece proving Alberta residency.**

IDENTIFICATION* **Driver's Licence with photo, plus one of the following:**

(If your Driver's Licence is not in English you are required to bring in a certified translation or a valid International Driver's Permit in English)

Passport + Work/Study/Visitor Permit (must have at least 90 days remaining)
OR
Permanent Residence Card/Certificate of Canadian Citizenship

***Neither temporary documents nor photocopies of documents will be accepted, all documents must be originals**

PROOF OF RESIDENCY* **One of the Following:**

Town of Canmore Tax or Water Bill
Residential lease or mortgage documents
Letter signed from employer on company letterhead
(Dated within the last 15 days)

Utility, telephone, gas or cable bill
Current bank &/or credit card statement
Income tax return
Pay Stub

***All proof of residency must be dated within the preceding 3 months.**

You will be required to surrender your out-of-country driver's licence to Alberta Registries
If you have *lost* your out-of-country Driver's Licence, an official written confirmation from the country's licensing authority detailing the content of the Driver's Licence (date first licenced & class of licence held) is require

If your out-of-country driver's licence has *expired*, full re-testing is required

Learner's Licences from other jurisdictions will not be exchanged for Alberta Learner's Licences
To obtain a full-class 5 driver's licence, proof of 2 years driving experience must be provided.
(Issue date on your licence/driver's licence history report/driver's abstract)
